Unfortunately this isn't the case, as certain allergens in the gloves can also cause dermatitis, such as type I (latex protein allergy) and type IV (delayed contact dermatitis). The causes of allergic reactions can be so complex that even changing from wearing latex gloves to nitrile gloves can exclude the possibility of type I over-sensitivity, the type IV over-sensitivity remains. For many allergy-prone wearers of gloves, this presents a major challenge. Moreover, there is also a risk of people who are yet to have suffered allergies developing hypersensitivities due to repeated exposure to allergens in gloves. And after the allergy has been triggered, people can suffer from it for the rest of their life. Preventing exposure to allergens is therefore the best way to prevent skin allergies.

In many cases, particularly those of frequent relapse, an employee who suffers from a work-related skin disorder is forced to stop working and can even lose their job. According to the latest information from the umbrella organisation of the German Statutory Accident Insurance Association (DGUV), some 21,063 cases of suspected occupational skin disorders were reported to the accident insurance agency in the year 2017. As recently reported by the Association of German Company Doctors (VDBW), this group of illnesses is therefore the leading reported occupational illness in Germany.
